

# PRIVATE PAY: PAYMENT POLICIES & PROCEDURES

**Chatty Child**<sup>TM</sup> is a personalized therapeutic center for children and their families conveniently based in downtown Manhattan. Treatment sessions and services are provided in a beautiful, state-of-the-art center or \*via teletherapy (remotely) if requested. The Chatty Child Center houses a large sensory room and individual treatment rooms. For children under 2, or those that need physical or medical one to one assistance, one person may accompany the child.

#### RATES:

The following are our rates for private speech, language, feeding therapy, or occupational therapy. Fully coded invoices can be submitted to your insurance to facilitate reimbursement. These prices are subject to change. A credit card is required to schedule a screening or evaluation. A credit card must be placed on file to receive a consultation or treatment session.

#### **Individual Treatment Sessions**

60 minutes: \$210 45 minutes: \$157.50 30 minutes: \$105

**Group Treatment Sessions** 

60 minutes: \$140

#### **Screenings/Consultation Rates**

Initial Consult / Initial Session: \$360, additional \$210 for a one page-written report. Additional consultations following initial consultation will be prorated at \$180 per hour

### **Formal Evaluations**

\*Includes standardized testing and a formal written report.

Rates range from \$750 to \$1,500, depending on the extent of testing needed.

#### **PAYMENT OPTIONS:**

## **Private Pay**

Invoices are coded to facilitate insurance reimbursement. We are an out-of-network provider. It is the

client's responsibility to check with your insurance company to see if and how many therapy sessions are covered per year, and the financial percentage of coverage per session. We cannot guarantee that your insurance carrier will reimburse you in part or in full, but we will, on request, provide all requested information to help maximize your reimbursement. When service begins we require a credit card and doctor's prescription on file. Invoices are mailed out monthly. If payment is not received within 10 days after receiving the invoice, your credit card will be charged automatically. \*Checks, cash and credit cards accepted as payment.

## **CANCELLATION POLICY:**

Cancellation notice is required 24 hours in advance of the scheduled appointment. If notice is not received, you will be billed for the scheduled session.

## **ADDITIONAL COMMUNICATIONS:**

All communications - beyond the treatment session time & allotted the last 5 minutes (at the end of each session to review carry over exercises) will be prorated at a rate of \$210 per hour.

This includes all communications related to the assessment, treatment & continued care of the patient. This includes: text messages, phone calls, emails, report writing, meetings with team members and/or school staff, as well as any other function related to the patient's care.

Please note we will not communicate with other team members without your direct & written consent. We will review care plans and treatment goals at the end of each session or weekly via email if you are not available at the time of the session. Anything beyond this 5-10 minute communication about weekly goals and progress will be prorated at the hourly rate of \$210 per hour.
